Planar passivated high commutation three quadrant triac in a SOT186A (TO-220F) "full pack" plastic package intended for use in circuits where high static and dynamic dV/dt and high dl/dt can occur. This "series BT" triac will commutate the full RMS current at the maximum rated junction temperature ($T_{j(max)} = 150 \, ^{\circ}$ C) without the aid of a snubber. It is used in applications where "high junction operating temperature capability" is required.





Fig. 1. RMS on-state current as a function of heatsink temperature; maximum values

Fig. 2. RMS on-state current as a function of surge duration; maximum values




Fig. 3. Total power dissipation as a function of RMS on-state current; maximum values






Fig. 4. Non-repetitive peak on-state current as a function of the number of sinusoidal current cycles; maximum values



Fig. 7. Normalized gate trigger current as a function of junction temperature




Fig. 9. Normalized holding current as a function of junction temperature






Fig. 8. Normalized latching current as a function of junction temperature





Fig. 10. On-state current as a function of on-state voltage




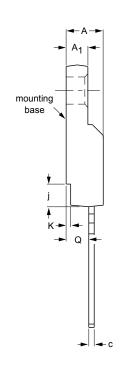
