
# KA78RM33R Low Dropout Voltage Regulator

## **Description**


The KA78RM33R is a low-dropout voltage regulator suitable for various electronic equipment. It provides constant voltage power source with surface-mount type package (DPAK). The dropout voltage is below 0.6 V in full-rated current 0.5 A. This regulator has over-current protection, thermal shut-down and the SOA (Safe operating Area) protection.




Figure 1. Block Diagram




Figure 2. DC Parameters

#### Notes:

- 2. C<sub>O</sub> improves stability and transient response. Refer to the figure 12 for ESR values of capacitors.




Figure 3. Normalized Output Voltage




Figure 5. Peak Output Current




Figure 7. Dropout Voltage vs. Temperature




Figure 4. Quiescent vs. Temperature




Figure 6. Output Voltage vs. Temperature




Figure 8. Dropout Voltage vs. Output Current




Figure 9. Output Voltage vs. Input Voltage




Figure 10. Quiescent Current vs. Input Voltage




Figure 11. Quiescent Current vs. Output Current





Figure 12. Output Stability vs. Output Capacitor Change
